#### § 1 Nature and duration of the internship

(1)	The practical work is carried out in the company listed above and lasts 12 weeks with a usual working time.				
(2)	The internship provider undertakes to train the student from

#### § 2 Obligations of the internship provider

The internship provider undertakes to,

- (1) introduce the student into scientific / engineering / economic work for the duration of the internship by assigning him or her to suitable projects / subprojects. It should be ensured that real use is made of the student's knowledge and skills so far acquired, and that the projects are innovative importance for the enterprise,
- (2) provide the student with a general impression of the tasks and functions of the enterprise by appropriate discussions with responsible persons in each case,
- (3) appoint an engineer as supervisor for the student's training for the abovementioned period in the company,
- (4) issue a certificate documenting duration, contents and success of the practical activity after the completion of the internship,
- (5) provide, if the student so desires, a certificate of employment

#### § 3 Obligations of the student

The student undertakes to,

- (1) carefully implement the tasks assigned to him or her as mentioned in § 2 and to increase his or her knowledge and experience as far as possible,
- (2) obey the instructions given within the framework of the internship by the enterprise and its representatives,

- (3) respect the discipline imposed by the enterprise, in particular work regulations and rules for the prevention of accidents as per instructions by the enterprise before the beginning of the internship,
- (4) agree to maintain secrecy about operations which by their nature or by special order require professional confidentiality. This also applies after completion of the internship,
- (5) comply with company times, immediately inform the enterprise about absences and in case of extended illness to provide a medical certificate no later than the third day of his or her absence,
- (6) handle with care tools, machines, equipment and devices as well as other enterprise facilities, materials and products placed at his or her disposal

# § 4 Time of probation and termination of the agreement

A 4 week probationary period is agreed upon, during which each party is legally entitled to terminate this agreement in writing without indication of reasons.

After the time of probation this agreement may be terminated for an important reason without compliance with a deadline or with a period of 4 weeks to the end of month.

The termination of this agreement must be in writing.

#### § 5 Leave

During the contractual period the student is not entitled to a vacation. The internship provider can grant a short-term leave from the internship for personal reasons.

## § 9 Final provisions

The contractual parties reserve the right to modify individual provisions of this contract if such modifications are required for particular reasons.

Modifications must be made in writing. Non-compliance with a provision of this contract does not affect the validity of the rest of the contract
